J. Walter Porter
(1900-1965)

A native of Kaufman County, Texas, Mr. Porter graduated from Texas A&M, class of 1922, and earned a Master's Degree in Civil Engineering at Harvard in 1924. In 1931, he helped organize the Gifford-Hill Pipe Company in Grand Prairie, Texas. Mr. Porter saw the need to sell business to the college and to bridge the gap between the college campus and industry. Mr. Porter felt that many people in the academic, professional, governmental, and even in the business world, fail to understand the workings of the competitive system and the motivating force behind it. He was determined to contribute to a better understanding of that system among his own employees, associates, and where he could, on college campuses. His death came on the eve of a scheduled three-day lecture program at Southwestern College in Winfield, Kansas. The J. Walter Porter Forum is a continuation of his efforts to increase this understanding.

Donna L. A. Isaacs-CocoGreen

Isaacs is President of CocoGreen, a consulting firm dedicated to educate, advocate, and rehabilitate communities to improve the health and well-being of residents while saving money.

A Leadership in Energy and Environmental Design (LEED) instructor, she prepares construction industry professionals for LEED accreditation and has conducted over 70 workshops nationwide. A dynamic community leader, her specialty is Green Rehabilitation, a combination of green building and historic preservation for the creation of a healthy resource efficient built environment. Donna Isaacs has over 20 years of experience in accounting, management and strategic planning.

Hiram Copeland, Mayor of Vidalia

Copeland, formerly LEPA Chairman in 1996, 1997, and 2007, has been Mayor of Vidalia since 1992. Before that, he served on the Vidalia Board of Aldermen for 12 years. He is past President of the Louisiana Municipal Gas Authority and is a member of the Gas Authority's Board of Directors and Pricing Committee.

A LEPA board member since 1992, Copeland was a LEPA Operating Committee member from 1993 to 1997, then from 2000 to 2007, then rejoined the Committee in 2010. Mayor Copeland has held a number of other positions, including Chairman of the Highway 84 Commission, President of both the Macon Ridge Economic Development District and the statewide Rural Economic Development District, Chairman of the Concordia Parish Economic Development District, board member of the Kisatchie Delta Regional Planning and Development District, and member of the Vidalia Chamber of Commerce. Mayor Copeland has also served on the Governor's Economic Development Task Force, the Mississippi River Parkway Commission and was voted 2010 Concordian of the Year.

Tony Davis-Natchitoches Chamber of Commerce

Davis is President of the Natchitoches Area Chamber of Commerce. He is a Natchitoches native and graduate of Northwestern State University where he received his BS in Business Administration. Tony is a licensed real estate broker and residential contractor and serves on the Board of Directors for the Louisiana Association of Chamber of Commerce Executives and the Board of Regents for Oklahoma University's Center for Chamber of Commerce Excellence program. He has served on several local boards, including the Jaycees, D.O.V.E.S. and the Board of Realtors.
